The Bidder having submitted the highest price and whose offer is substantially responsive to the requirements specified shall be selected for award of the transaction and shall be referred to as the BUYER.

3. Prices

Prices quoted shall be firm and fixed during validity period of quotation and until the finalisation of the transaction.

4. Payment

The successful bidder shall effect payment along with all required documents. The final payment shall be adjusted to include Value Added Tax (VAT) at 15% at time of settlement to the **Finance Department of the MBC**.
